Approval of Agenda

Mayor Dillan called for a motion to approve the agenda. Johnson made a motion for approval, seconded by Larsen. With no further discussion, all in favor of the approval of the agenda; motion passes.

Ordinances and Resolutions

Ordinance #523 – Amending Traffic Code Chapter 73 Sections 73.22 and 73.27 (Golf Carts) Second Reading: Mayor Dillan called for a motion to approve. Motion by Muller, seconded by Johnson. Mayor Dillan stated this Ordinance would become effective January 1, 2025. No further discussion. All in favor of Amending Traffic Code Chapter 73 Sections 73.22 and 73.27 (Golf Carts). Motion passes.

Ordinance #524 - Amending Traffic Code Chapter 70 Section 70.11 (Mini Trucks and UTV's) Second Reading: Mayor Dillan called for a motion to approve. Motion by Gahm, seconded by Johnson. Mayor Dillan stated this would be effective January 1, 2025 also. Councilmember Larsen asked if this affected just the citizens of Milaca and not the people that come into town? Mayor Dillan explained that if people take the most direct route, it should not affect them. City Manager Pfaff stated this was mostly for the residents of Milaca who use UTV's regularly in Milaca. If people just come in on their side by sides to get gas or eat, it would not apply to them. No further discussion. Ordinance #525 – Adding Motorized Golf Cart Fee and Mini Truck/UTV Fees to Chapter 34. Mayor Dillan called for a motion to approve. Motion by Muller, seconded by Gahm. Mayor Dillan said this was effective January 1, 2025 as well. No further discussion. All in favor of Adding Motorized Golf Cart Fee (and Mini Truck/UTV) to Chapter 34 (\$50 for 3 years). Motion passes.

Ordinance #526 – Amending Traffic Code Chapter 74 Schedule V Motorized Golf Carts; Restricted Areas Second Reading: Mayor Dillan called for a motion to approve. Motion by Johnson, seconded by Muller. Muller asked if this was effective January. City Manager Pfaff stated it would be to keep them all effective same date. No further discussion. All in favor of Amending Traffic Code Chapter 74 Schedule V Motorized Golf Carts; Restricted Areas. Motion passes.

Ordinance #527 – Amending Chapter 90 Recreation Section 90.04 (G) Disturbing the Peace-Conduct Second Reading: Mayor Dillan called for a motion to approve. Motion by Larsen, seconded by Muller. Kuechle Underground came in at \$85,000.00 and Northern Lines Contracting came in at \$94,355.00. Kirkeby recommended going with Kuechle as they have done work before in the city and came in cheaper. Mayor Dillan called for a motion to approve quote from Kuechle in the amount of \$85,000.00. Motion by Muller, seconded by Johnson. No further discussion. All in favor of quote from Kuechle. Motion passes.

Public Works- Pay Request #1 to Northern Lines Contracting in the amount of \$13,376.00 for 110th Avenue Improvements Project: Mayor Dillan called for a motion to approve. Motion by Johnson, seconded by Larsen. No further discussion. All in favor of Pay Request #1 to Northern Lines Contracting in the amount of \$13,376.00 for 110th Avenue Improvements Project. Motion passes.

City Manager Pfaff stated the ordinances will be presented to Planning Commission again on August 8 to finalize and then send to council August.

Budget: City Manager to meet with Muller and Johnson

EDC: Mayor Dillan commented that he met with Tom Fish who is head design of the University of MN and Molly Zens of the Empowering Small MN Cities Grant earlier this month. They toured the city and met with a group and had a good discussion. The plan is to have community input so they are looking at August 30th or September 6, both home football games, and hopefully having Heggies serve pizza and hearing input from the community. Then do one more event at the home block party and take all this information and then plan for the future of Milaca.
